

## Wave 13: Module summary

Wave 13 contains 31 modules, 4 of which are new (Mental health conditions, Job Search, Other Work and Gambling). The [long-term content plan](#) lists the Waves in which all the modules were last asked and when they will be asked again. Most of the rotating modules for Wave 13 were last asked in Waves 10 and 11. This table lists the modules in the order they are asked within the Wave 13 questionnaire.

Please note:

**Soft checks** are used to double check an answer. The respondent can proceed through the questionnaire without changing their answer e.g. You have said you have 15 mortgages?

**Hard checks** are used to double check an answer but the respondent cannot proceed through the questionnaire without editing their response e.g. The date you moved address is set in the future.

**Rotating Modules** do not always carry every question at each rotation. Use the [Variable Search](#) tool to establish in which Waves the variables appear.

**Consent questions** such as those in the module **Education Consent** are mostly asked every 3 years to those who have not already consented to data linkage e.g. 16+ year olds previously given consent by their parents and those who have previously refused consent less than twice before.

The column 'Changes in questions (variables) or responses' in the table below provides a detailed list of modifications within each module. We have not distinguished between minor and major changes, to see the exact change, please take a look at the [questionnaires](#).
